Re: Staying your course on combating IUU fishing by delivering digital & effective fisheries control

Dear Commissioner Kadis,

We welcome your recent statement that EU Regulation 2023/2842, adopted by the European Parliament and Member States just over 2 years ago, remains a major political achievement.ⁱ The European Court of Auditors also deemed this reform necessary to digitalise paper-based systems, to ensure dissuasive sanctions and to prevent “control shopping”, where operators exploit the weakest link.ⁱⁱ This is no time to risk its delay or weakening.

We urge you to stick to your commitments to focus on the “*gradual but timely and full implementation of the revised fisheries control system*”ⁱⁱⁱ including CATCH and the Fisheries Control Regulation and so deliver on Europe’s zero-tolerance to illegal, unreported and unregulated (IUU) fishing.

Strong EU rules to detect and deter IUU fishing are indispensable. Not just for protecting Europe’s fish populations from unmonitored quota uptake, but for credibly asking third countries to do more to fight illegal and unsustainable fishing and avoiding illegal seafood entering the EU market.^{iv} The loopholes that legalised misreporting contributed to stock collapses in the Baltic Sea^v and proposals to introduce similar loopholes in catch reporting raised questions from the EU’s partners, including the UK.^{vi}

At the UN Oceans Conference in Nice last June, President von der Leyen stressed that the EU can “*crack down on this illegal fishing that destroys our ecosystems*” with the digital tools it has, to level the playing field and to “*produce at least half of our marine food right here in Europe*”.^{vii} Accordingly, Member States should not delay, but deliver on what they promised to do, and what advisory councils jointly demanded.^{viii}

Concretely the undersigned urge you - as the “Guardian of the Treaties” - to continue to:

- **remind Member States of their basic obligations**, with enforcement actions if needed, including
 - to take effective measures to uphold the community system against IUU fishing,^{ix} including by establishing dissuasive penalties;^x and
 - to properly monitor the uptake of quotas and contribute to the Common Fisheries Policy (CFP) objectives by ensuring they have accurate and comprehensive information and data on fishing opportunities;^{xi} and
 - to ensure adequate financial, human and technical resources for control of activities in the scope of the CFP.^{xii}
- **encourage Member States to expedite use of available EU funding instruments**, including the European Maritime, Fisheries and Aquaculture Fund, to support operators and authorities in preparing to use the digital tools that they mandated in EU Regulation 2023/2842; and
- **address, at technical level, any challenges** users of these digital tools face while remaining firmly within the boundaries of the applicable legal framework.

Commissioner, your leadership sends a clear signal. We encourage you to stay on this course. We stand ready to support the full and effective implementation of a control system that Europe's fisheries, coastal communities and citizens urgently need.
